

1. ELIGIBILITY: The Townsend Lumber Inc./Bass Lake Sawmill Amp Up Your Yard Facebook Contest ("Contest") is open to legal residents in Ontario who are eighteen (18) years or older at the time of entry. Not eligible are employees of Townsend Lumber Inc. or Bass Lake Sawmill, its respective parents, subsidiaries, affiliated companies, advertising and promotion agencies, and the immediate families and persons living in the households of each of these individuals. Any web pages, advertisements and promotional materials relating to the Contest are intended for viewing only within the geographic area described above and by Eligible Participants. You are not authorized to participate in the Contest unless you are located within the geographic area described above and are an eligible participant. 4. ENTRY: You can enter the Contest by submitting, during the promotional period, via email to contest@townsendlumber.com a minimum of three (3) photographs of a Pergola or Party Pavilion Building Kit project that you completed (that includes the use of Sponsor's lumber products and Simpson Strong Tie Outdoor Accents in such photographs). The entry photos must be formatted as follows: project, your last name and name of retail location materials were purchased. Examples: pergola_LASTNAME_BassLakeSawmill.jpg or pavilion_LASTNAME_TownsendLumber.jpg. All entries must be received by Sponsor **no later than 11:59 P.M. EDT on September 30, 2021**. Only one entry per person and per household. Multiple entries may disqualify you from eligibility to enter the Contest. In the event duplicate entries are received from any person or e-mail address, the first entry processed will be considered the only valid entry received. In the event of a dispute, Internet entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry. A potential prize winner will be notified by email on or about September 2, 2021 by a representative of Sponsor. **NOTE: Due to lumber supply issues and hardware shipping delays as a result of the pandemic, the entry deadline has been extended to September 30, 2021 at 11:59 P.M. EDT and therefore, the potential prize winner will now be notified on or about October 15, 2021 by a representative of Sponsor.** If a potential winner cannot be reached within three (3) calendar days of the first notification attempt or any prize notification is returned as undeliverable, that potential winner may be deemed ineligible and an alternate potential winner will be selected from the remaining eligible entries.
